All volunteers are appointed by and serve at the pleasure of the Fire Chief. The following is a partial list of the requirements for each position. The Fire Chief will, from time to time, update the requirements as deemed necessary to meet the needs of the District.

FIREFIGHTER/EMS-Provider

- Must hold a Colorado Firefighter 1 certification of higher
- Must hold a Colorado Hazardous Materials Operation Level certification or higher
- Must hold a Colorado Medical 1st Responder w/CPR certification or higher
- Must complete NWCG's FFT2 training (S-130, S-190, L-180 plus RT-130 annually)
- Must obtain FEMA's I-100, I-200, and I-700 certifications
- Must actively participate in emergency response
- Must actively participate in work details, duty details, and trainings
- Must participate in Elk Creek's Health & Wellness Program
- May participate in Elk Creek Driver Operator Program

EMS-Provider

- Must be able to obtain a Colorado Hazardous Materials Awareness Level certification or higher
- Must hold a minimum Colorado Medical 1st Responder w/CPR certification
- Must obtain FEMA's I-100, I-200, and I-700 certifications
- Must actively participate in emergency response
- Must actively participate in work details, duty details, and trainings
- Must participate in Elk Creek's Health & Wellness Program
- Must participate in Elk Creek Driver Operator Program up through Ambulance Driver

Support Team

- NO emergency response
- May work in a non-operational support role such as an IMT (Incident Management Team)
- Appointed by the Fire Chief to fill specific roles such as but not limited to:
 - Chaplin
 - Logistical Support
 - Health & Wellness Advisor
 - Training Specialist
 - Finance / Administrative Support
 - Public Information
- May participate in Elk Creek Driver Operator Program up through the staff cars
